**Tuition and Fee Information**  
**2024-2025**

**Admission Requirements:**

- Kindergarten – Children must be 5 before September 1<sup>st</sup>.
- Young 5’s – Children must have completed at least one year of 4-year-old preschool.
- All new students to Immanuel, as well as Kindergarten and 7<sup>th</sup> grade, must turn in an up-to-date immunization record or waiver directly from the health department by 10/1 of the registration year. Due to State Requirements, students must have immunizations or waivers by 10/1 to remain at school.
- All new students must have a copy of their birth certificate.

**Fees (non-refundable):**

- Education and Technology Fee - \$150/student (y 5’s – 8<sup>th</sup> grade) due annually at the beginning of the school year.
- Re-enrolling families:
  - \$100 deposit per child by May 1<sup>st</sup> of each year to register for the following school year.
  - If deposit is not made, \$25 will be added each following month and **only the \$100 will be applied towards tuition.**
    - After May 1<sup>st</sup> – registration cost - \$125/student
    - After June 3<sup>rd</sup> – registration cost - \$150/student
    - After July 3<sup>rd</sup> - registration cost - \$175/student
    - After August 1<sup>st</sup> – registration cost \$200/student
- Financial aid is available, if needed. Families must apply.

Tuition is payable in 9 monthly payments.
